## LAPSE OF MEMORANDUM OF UNDERSTANDING IN RELATION TO A POTENTIAL ACQUISITION

This announcement is made by Shentong Robot Education Group Company Limited (the “Company”) pursuant to Rule 17.10 of the GEM Listing Rules and Inside Information Provisions under Part XIVA of the SFO.

References are made to the announcements (the “**Announcements**”) of the Company dated 15 June 2023 and 14 June 2024 in relation to the MOU and the Potential Acquisition. Capitalised terms used herein, unless otherwise defined, shall have the same meanings as those defined in the Announcements.

The Board of the Company announces that since the Parties to the MOU were unable to reach an agreement on the terms of the Formal Agreement after negotiations in good faith during the Exclusivity Period, the MOU lapsed on 14 June 2025. Pursuant to the MOU, all obligations and liabilities of the Parties under the MOU shall cease and terminate, and none of the Parties hereto shall have any claim against the others.

The Directors consider that the lapse of the MOU does not have any material adverse impact on the financial position and operations of the Group.
